




DAC Cable

EU-type Power Cord







3. Hardware Installation

3.1 Network Connection

- 1. Insert the connector into the slot (port 1~12 of this switch).
- 2. Pull the release latch to remove it.



3.2 Rack-Mounted Installation

The switch can be installed easily by using rack mount kit.

- 1. Fasten the rack mount kit on both sides of the VigorSwitch using specific screws.
- 2. Then, install the VigorSwitch (with rack mount kit) on the 19-inch chassis by using other four screws.






4. Software Configuration

Before configuring the switch, perform the following steps:


1. Set up a physical path between the switch and a PC. Insert one end of the DAC cable connector into the slot (port 1~12 of this switch); and insert the other end of the DAC cable into the slot on the network card on your PC.




If a PC directly connects to the switch, you have to setup the same subnet mask for PC and the switch. Default values of the managed switch are listed as follows:
